# Is there a limit on the number of people I can nominate?

No. If you would like to nominate more than one person please specify the percentage that you would like them to receive. If you would like to nominate more than three people, please write their details on a separate sheet of paper with your name and policy number at the top, and send it back to us with the declaration.

If you would like your benefits to be paid to your estate upon your death, please write 'To My Estate' in the 'Name' box.

### Can I change my mind?

Yes. You can change your nominees as many times as you would like, but we will only look at the most recent form when making a decision.
